

Frequently asked questions

Parking Policy

1. Which types of parking permits can I apply for?

- Day permit valid for a minimum of 12 hours
- Annual permit 5:00am – 6:00pm (only valid on auction days from 5:00am – 6:00pm)
- Annual permit (24/7 parking for 1 calendar year: January through December)

2. Where may I park with a parking permit?

A parking permit entitles you to park in all car parks suited to your type of company vehicle.

3. When do I receive my parking permit?

Royal FloraHolland endeavours to issue you with the parking stickers within five business days.

4. Where can I buy a day permit?

Day permits are available from Security. This is located next to FloraHolland's main entrances.

5. What is the cost of a day permit?

The cost of a day permit is €10.00 per 12 hours.

6. Where may I park with a day permit?

A day permit entitles you to park in all car parks suited to your type of company vehicle. The signage at the parking facility will indicate this.

7. Do I require a permit for my trailer/semi-trailer?

- If the trailer and/or semi-trailer is connected to your vehicle you do not need an additional sticker.
- You must apply for an annual sticker for a disconnected trailer and/or semi-trailer. You can then park the trailer and/or semi-trailer at a specially equipped parking facility.
- If necessary, annual permit holders will receive a special sticker with their permit for the trailer and/or semi-trailer. Please send a copy of the registration certificate for the trailer and/or semi-trailer with the permit application for your company vehicle.
- Annual permit holders may park the trailer and/or semi-trailer separately for a maximum of 3 x 24 hours.

8. Can I request a parking permit for each company vehicle?

You may only apply for one parking permit for the company vehicles registered in your name. Send a copy of the registration certificate along with your application.

9. How are the permit charges billed?

- If you have an account number with Royal FloraHolland, The costs will be deducted via the services invoice.
- Day parking permits can either be paid for directly in cash or via debit card at Security.

10. For how long are the parking permits valid?

The parking permits are valid for one calendar year (January-December).

11. Where should I display my permit?

You should attach your permit to the upper left of your windscreen, so that it is well visible. Place the sticker for the trailer and/or semi-trailer on the front above the triangle/drawbar.

12. What should I do in the case of a newly purchased company vehicle?

Please notify us through email: parkeervergunningen@royalfloraholland.com and please include a copy of the registration certificate for the vehicle and the trailer and/or semi-trailer.

You will receive a confirmation that you can pick it up at the location provided by you and you return the old sticker. We charge a € 25.00 administration fee for the new sticker, which will be settled through the services invoice.

If you do not submit the old sticker (day/night permit), we are forced to charge the full year rate for the new sticker.

13. Free Permit

Box tenants will receive 1 free 24/7 (day/night) parking sticker for every 500 m2 rented box space. These free of charge permits may exclusively be granted to personal vehicles of which the license plate is held in the name of the box tenant. Please include a copy of the registration certificate for the vehicle along with your application for a new parking sticker.

Collective transporters will receive 1 free 24/7 (day/night) parking sticker for every 500 m2 rented box space and 1 free 24/7 parking sticker per leased dock
